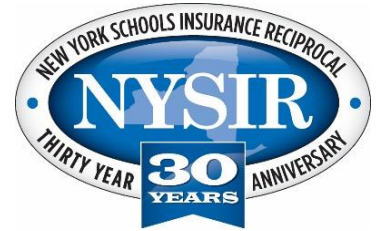




Advanced Bus Driver 10 Hour Training Course

Advanced Bus Driver Course 604.040

New York's children deserve safe transportation. Everyday stress and daily routine can sometimes hinder a driver's mental outlook and attitude toward the job. This advanced course will offer an opportunity for veteran drivers to recharge their batteries while sharing experiences with other drivers. We will cover current laws and regulations, self-assessment and revisit the basic operations that will help ensure safe student transportation. Take this professional development opportunity to allow your drivers to share, learn and reflect on how they complete their daily tasks.

This Advanced Course is approved by the NYS Education Department and must be taught by a NYSED approved School Bus Driver Instructor (SBDI). Drivers who successfully complete this course will receive a NYSED Advanced Course certificate and will be eligible for NYS DMV Point/Insurance Reduction.

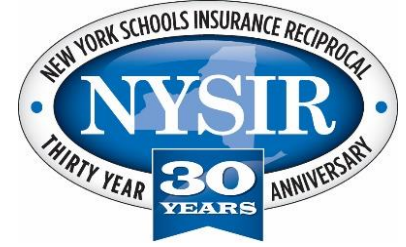
