Supplies

301 General Supplies

Includes office supplies (except for technology office supplies), copier overage usage, postage usage, paper, books, periodicals, classroom supplies, instructional supplies, food, gasoline, water, groceries, gases, propane, maintenance supplies, cleaning supplies, hardware, small tools, parts, subscriptions, tests

Supplies purchased for districts should be designated with the extension number assigned to that district (ex. 523-6368-301-133, which would be for Cooperstown). Extension numbers used to identify districts can be found below.

360 Reimbursables

Supplies purchased and used by student programs but then later sold as part of a project or service. Revenue received for the project or service replenishes the budget for the supply expense.

Cost of classified advertising and billed back to districts.

399 Technology Supplies

Technology supplies purchased for districts should be designated with the extension number assigned to that district (ex. 523-6368-200-133, which would be for Cooperstown). Extension numbers used to identify districts can be found below.

400 General Services

Includes pest control, garbage disposal, recycling, advertising, linen service, water testing, shredding, CPR training, coach bus, inspection fees, webinars, internet, records vault storage, memberships, dues

401 Telephone

Includes usage charges for office lines and cell phone usage/plans

402 Electricity

415 General Repair

Includes equipment repair, building repair, auto and truck service/repair (if purchasing parts only then use 301)

419 Contractual Services

Services that require a contract – maintenance agreements, leases, rentals, ancillary fees, consultants

Includes attorneys, accountants, auditors, architects, appraisers

454 Travel

Includes all mileage reimbursement (in and out of district), tolls, parking, meal reimbursement, conference/workshop registrations, hotel rooms, student conferences

Includes reimbursements to districts, Itinerant substitutes, workshop participants, contractual payment to other BOCES
